### INFORMATION ABOUT THE SERVICE

#### SERVICE DESCRIPTION and KEY INFORMATION

**Bold SIP Trunks** are the smartest, most cost effective way to connect your business to the public switched telephone network (PSTN). Enabled by our Tier 1 Carrier's unmatched reliability and scalability, the service allows you to make and receive phone calls by connecting a range of devices to a suitable broadband internet service.

The monthly access fee includes a single SIP Trunk with allocated SIP Channels that determine the number of concurrent phone calls the service is able to support. Each SIP Trunk is allocated an Australian phone number and you can port-in your existing telephone number if required. This service is not appropriate if you require an uninterrupted phone service with access to 000 emergency services and will not function in the event of a power failure.

#### MINIMUM TERM and PLAN CONDITIONS

Minimum term is 36 months. Please note that a business account can only have one type of SIP plans. All SIP services must either be on FLEXI plans or ULTIMATE plans, combination of both types of plans is not available.
